Putting a price tag on Ukraine's overall reconstruction cost remains difficult, not least since the war is not fully over, but experts estimate the cost to be anywhere **from \$565bn, up to \$1trn**. This does not include the multi trillion-dollar losses accrued across the globe due to inflationary pressures.

Global prices of food, energy and metals, have soared since the invasion of Ukraine, quickening inflation and diluting buying power for businesses and families alike.

An UNCTAD rapid assessment of the war in Ukraine's impact on trade and development confirms a rapidly worsening outlook for the world economy, underpinned by rising food, fuel and fertilizer prices.

Addressing the global shocks caused by the war by renewing trade relationships, supporting new initiatives for regional and international cooperation, and preparing for the overall economic recovery of Ukraine is essential for global economic well-being.

A FORUM WITH A TRULY GLOBAL IMPACT

The war is having a devastating impact on the global economy – and it will only get worse if we do not do something now.

The invasion of Ukraine by Russia is a major blow to the global economy with the entire global economy feeling the effects of inflation. Ukraine and Russia are key suppliers of essential items including energy, food, fertilizers and even neon for semiconductors; supplies of which are now threatened by the war. Shipments through Black Sea ports have already been halted, with potentially dire consequences for food security in poor countries. Gas shipments to Bulgaria and Poland have also been halted by Russia.

Impacts of the war affecting the global economy has been seen in three main areas:

- Higher prices for commodities like food, energy, steel and ores, which is eroding the values of incomes and pushing up inflation. Russia and Ukraine are major commodities producers, and disruptions have caused global prices to soar, especially for oil and natural gas. Food costs have jumped, with wheat, for which Ukraine and Russia make up 30 percent of global exports, reaching a record.
- The neighbouring economies of Bulgaria, Hungary, Latvia, Lithuania, Poland, Moldova, Slovakia and Romania, in particular, are grappling with disrupted supply chains and remittances.
- Historic refugee numbers has created a humanitarian crisis, not seen in Europe since World War II.

FREQUENTLY ASKED

QUESTIONS

Where will the event be held?

The event will be held in Istanbul, Turkey. Venue information will be released to ticket holders only.

How do I register?

All registrations are taken online at www.tgeif.org. We do not accept registrations via email or telephone.

How much do tickets cost?

Tickets are allocated free of charge to select attendees for the event. All attendees must apply online prior to the event in order to be allocated a ticket.

How many people are expected to attend?

We expect 1000+ dignitaries, government ministers, fortune 500 company CEOs, foreign direct investors, legislators, humanitarian organizations, chambers of commerce, venture capital organizations, trade commissioners, embassies; and related parties.

When is the deadline for registration?

Registration is open now and the organizers will vet all registrations as they are received. If you are approved, you will receive a letter of confirmation. Registration will remain open until we have reached capacity for the event, but not later than 7th June 2022.

Do you have a limit on individuals per organization?

Yes. Each organization is allowed to register a maximum of 3 representatives for the Forum.

Can I complete a bulk registration for more than one attendee?

Bulk registration is not available. Each attendee will need to register individually.

I am a member of the press. Do I need a ticket?

For security reasons, all attendees are required to have a pre-issued ticket to the venue.

When will I receive my ticket?

Applicants for tickets will receive their final approval in the first week of June 2022.

Does attendance include travel and accommodation?

Unfortunately not. Budgetary constraints because of the war do not allow for paid airfares and accommodation.

I did not receive a confirmation; am I registered?

If you did not receive a confirmation email, please contact our registration team at tickets@tgeif.org.

Do I need to present my ticket and/or identification to enter the venue?

Yes. You will be asked to present your identification and ticket upon entry. The name on your ID has to be identical to the name on your ticket.

How can I find out if I need a visa to enter Turkey?

Visa requirements change from time to time. We therefore recommend that when you are making your travel plans, check the current visa requirements on the website of the Ministry of Foreign Affairs, Consular Services Website here: <https://www.konsolosluk.gov.tr/>

When should I book my airline ticket and accommodation?

It is recommended that you only book your ticket once you have received a formal letter acknowledging your place at the conference. Under no circumstances will the organizers be responsible for airfare refunds or other expenses associated with travel or accommodation bookings.
